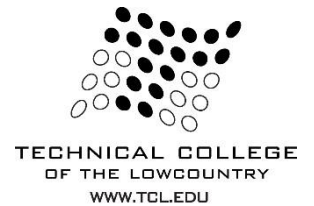

DECLARATION OF INTENT



*****THIS IS A FEDERAL FINANCIAL AID REQUIREMENT. PLEASE READ CAREFULLY*****

What's new?

The federal government now requires students to complete and submit a "Declaration of Intent" to confirm a student's intent to take all of his or her classes in a particular semester.

How does this affect me?

Our records indicate you are currently receiving federal financial aid and are enrolled in one or more modules or "mini-semester" during the semester, meaning your classes have different start dates. Our records indicate you may have stopped attending one or more of your classes. Under the federal rules, you must let us know if you plan to attend the rest of your classes that are scheduled to begin at a later date during the same semester. If you do not inform our office you could forfeit your financial aid.

What do I have to do?

To inform the TCL Financial Aid Office of your intent to attend your later start sessions, you must sign and return the attached "Declaration of Intent" form to the Financial Aid office no later than **ten days from the date you cease attending classes.**

What will happen if I don't take care of this?

Failure to submit will result in serious consequences. The TCL Financial Aid office will remove your funding for the remaining courses in Spring and return all or part of your aid to the federal government. If you have a student loan, it will be cancelled for the remainder of the term and it will not be recertified. If you are waiting for a refund due to a credit balance, you will not be eligible to receive it until you have signed and returned this form to the TCL Financial Aid Office. These rules are based on federal regulations, not TCL's policies, and we are legally bound to follow and administer them.

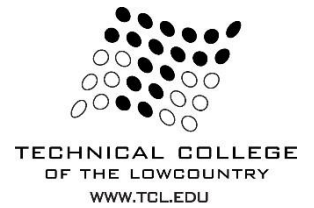
